- Non-Integrated (Medicaid only), this category has been split between recipients with Medicare coverage and those without.

MSHO and SNBC integrated must have both Medicare Part A and Part B.

Medica PINs program in Dakota County was sunset December 31, 2016. Most enrollees were transitioned to Medica SNBC or another SNBC plan.

SNBC enrollees age 65 or over were transitioned to an elderly program (MSC+ or MSHO) effective January 1, 2017.
