2014 Legislative Session Highlights





Legislative Update VPC

- ▶ The Minnesota Child Welfare Training System hosted Legislative Update VPC's in July.

Selected Legislative Changes

Child Welfare and Children's Mental Health

Data Entry Requirements: Screened Out Child Maltreatment Reports

- ▶ “For reports alleging child maltreatment that were not accepted for assessment or investigation, counties shall maintain sufficient information to identify repeat reports alleging maltreatment of the same child or children for 365 days from the date the report was screened out. The commissioner of human services shall specify to the counties the minimum information needed to accomplish this purpose. Counties shall enter this data into the state social services information system.”
- ▶ Minnesota Statutes, section 626.556, subdivision 11c

How to Screen Out Child Maltreatment Reports in SSIS

When screening out a report, workers should:

- create an SSIS intake workgroup with an attached child maltreatment report
- enter the children and parents as clients in the intake workgroup
- enter a narrative as to the nature of the concern
- enter the allegations (each report must have at least one), including alleged offenders and alleged victims.

Referral to PSOP

- ▶ Screened out reports involving risk that does not meet the standard of an accepted child maltreatment report can be referred to your agency's Parent Support Outreach Program to offer early intervention supports and services to families. This can be done without requiring the entry of a separate Intake.
- ▶ The worker should change the Intake program to "Parent Support Outreach" and enter "Open for Assessment-Intake complete" in the "Close Reason" field. The Child Maltreatment Report remains screened out.

More Information Available

- ▶ Intake workgroups are retained for a four-year minimum. No additional efforts will need to be made to meet the mandated screened out retention of 365 days.
- ▶ An email containing these requirements was sent to local agency directors from Assistant Commissioner Erin Sullivan Sutton earlier this summer. Directors were asked to share this information with staff, particularly child protection screeners.
- ▶ A bulletin from policy staff with more details of specific requirements will be published this fall.

Child Maltreatment Reports: Household Members Who Are Registered Predatory Offenders

- ▶ The law regarding this did not change this session.
- ▶ The local agency must take information that a parent or household member of a child has committed a violation which requires registration as a predatory offender and accept it as a child maltreatment report.

Trial Home Visits: Voluntary Foster Care for Treatment

- ▶ Purpose is to provide “sufficient planning for supports and services to the child and family to meet the child’s needs following treatment so that the child can return to and remain in the parent’s home.”
- ▶ Parent and the responsible social service agency must jointly agree to the THV. Either party may terminate with ten days’ written notice.
- ▶ Agency maintains placement care and responsibility. THV cannot exceed six months.
- ▶ Minnesota Statutes, section 260D.12



Functional Assessments for CMH

- ▶ CMH case managers are no longer responsible to complete functional assessments for children on their caseload.
- ▶ The functional assessments have been part of the Individual Family Community Support Plan (IFCSP). This will be changing.
- ▶ Minnesota Statutes, section 245.4881, subdivision 3

Smoke-free Environments for Children in Foster Care

- ▶ Generally, foster homes must be smoke-free environments for children. Statute outlines specific provisions of what this means and consequences for failure to comply.
- ▶ Placement with a relative cannot be delayed based on the relative's inability to maintain a smoke-free environment unless the relative is unable to provide for the immediate health needs of the child.
- ▶ Native American or religious ceremonies involving the use of tobacco are excluded from these provisions.
- ▶ Minnesota Statutes, section 260C.215, subdivisions 6 and 9

Kinship Placements and Kinship Assistance

- ▶ Kinship Placement Agreement
- ▶ Minnesota Statutes, section 260C.515, subdivision 4
- ▶ Guardianship Assistance changed to Kinship Assistance
- ▶ Minnesota Statutes, Chapter 256N

Background Studies

- ▶ In the past, a licensed child foster parent that wanted to adopt a child in their home had to complete an adoption background study prior to the adoption.
- ▶ Because of the revisions to statute, a new background study is no longer required to move a child to permanency and possibly qualify for Adoption Assistance or Kinship Assistance.
- ▶ The foster parent's background study must have been completed on or after July 1, 2007.



Northstar Care in SSIS

- ▶ Northstar Care necessitates a large volume of new functionality within SSIS as well as changes to existing functionality.
- ▶ The majority of changes for social workers are scheduled to be released in 14.4 and 15.1.
- ▶ SSIS will work to enhance Northstar-related functionality in 2015 and beyond.

Training on Northstar Care

- ▶ Child Safety and Permanency staff are developing wide-ranging training on Northstar Care.
- ▶ Trainings will be tailored to different populations whose practice will be impacted by the implementation of Northstar Care.
- ▶ A significant number of trainings are currently available for registration via Trainlink.

Service Plans

- ▶ Last year, SSIS announced plans to compile all service plan changes in our fourth quarter release.
- ▶ This was to accommodate legislative changes and would benefit developers and local agency workers.





Service Plans: Upcoming Changes

- ▶ Northstar Care for Children requires modifications to two of the out-of-home placement plans. Those will be released in 14.4.
- ▶ The Individual Family Community Support Plan (IFCSP) will be modified because of legislation passed last session. This will likely occur in 15.1 or 15.2.
- ▶ Other changes to plans are currently on hold unless they are mandated by state or federal law.



Diagnostic Codes: Mental Health

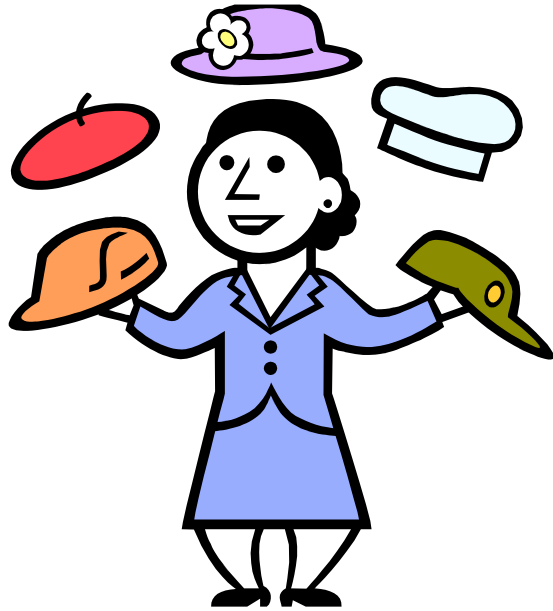
- ▶ The federal government has delayed implementation of ICD-10 until October 1, 2015. SSIS is working to add ICD-10 codes according to the new timeframe.
- ▶ The American Psychiatric Association released the DSM-5 in 2013. At this time, SSIS does not plan to add DSM-5 codes to the application.

Mobile App

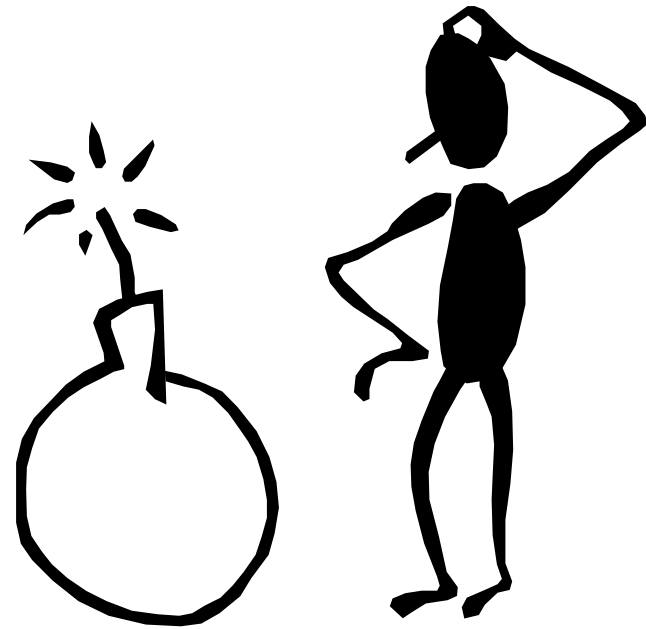


- ▶ The Mobile App, also known as mCase, has been delayed, but progress is being made.
- ▶ Two agencies will be piloting read-only access in 14.3, St. Louis County and Southwest Health and Human Services.

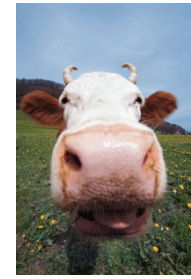

“Forty-two, and he had hit that stage where more and more he recognized recurrent patterns of behavior in humanity in general and himself in particular. This workaday predictive ability solved pretty much nothing and in fact could be a source of frustration and pique, but the upshot was, it made life more navigable.
