	The issue is occurring when there are two consecutive placements with the same Bus Org/Providers, and only affects payments for one day (where the payment service start date = the payment service end date) and where that payment service start/end date falls within the date range of both placements. The system is not matching the payment with the correct placement, and so is not presenting the correct proofing messages or calculating the correct "15th day of placement" to display in the short message text. It is displaying multiple proofing messages.		
Fiscal - Child Foster Care Report	This issue can affect 1288, 1289, 1290, 1291, and 1297, so a fix is needed for all.	The work-around is to shorten the earlier placement end date by one day, so that it is not the same as the payment date, until we can implement a fix.	SSIS 23.1

Instead of using the Action menus to Save, use the "Save" toolbar button. Then to continue processing the arrangement, select the row in the grid for the arrangement that was just saved. The menus are then available as expected. This could happen in other grids in SSIS when the "Group By" grid option is selected, and the focus is not on the correct grid row when creating a new record. Permanency	Adding a "New QRTP Family and Permanency Team" without saving, then using the Action Menu to add a "New Team Member" results in an "Access violation" error. The issue does not occur if "Save" is performed after the add of the QRTP Family and Permanency Team and before adding the New Team Member. Permanency	Applies to: group facilities with either a LNDX license, or a manually entered license that has the IV-E Facility Type of "Out-of-state child residential facility" (OSF) or "Tribally licensed/approved child residential facility" (TR). Incorrect QRTP Extend Placement Review (EPR) results are received when the only payments for the placement/Bus Org have a Title IV-E sub code that does not have a Service Provided of QRTP (is not certified for QRTP).
