Assisted Living Report Card updates

On Oct. 28, 2025, DHS published new ratings and corrected 14 previously published ratings for its [Assisted Living Report Card](#).

New ratings

We published new resident health, safety and staffing ratings from surveys conducted by the Minnesota Department of Health (MDH) between March 1 and May 31, 2025.
