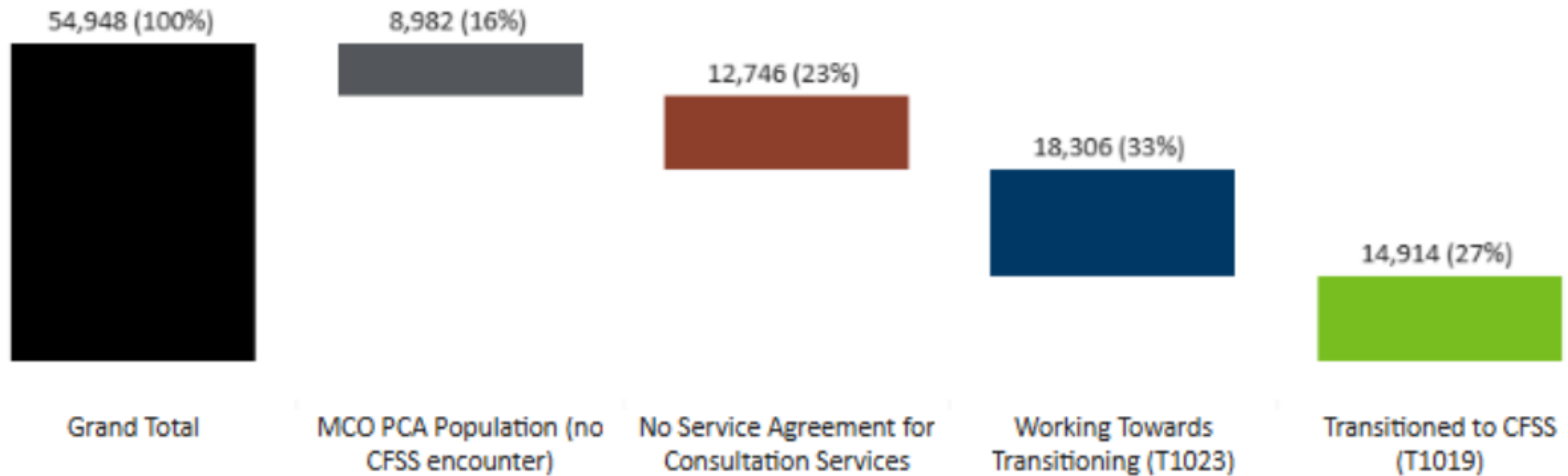

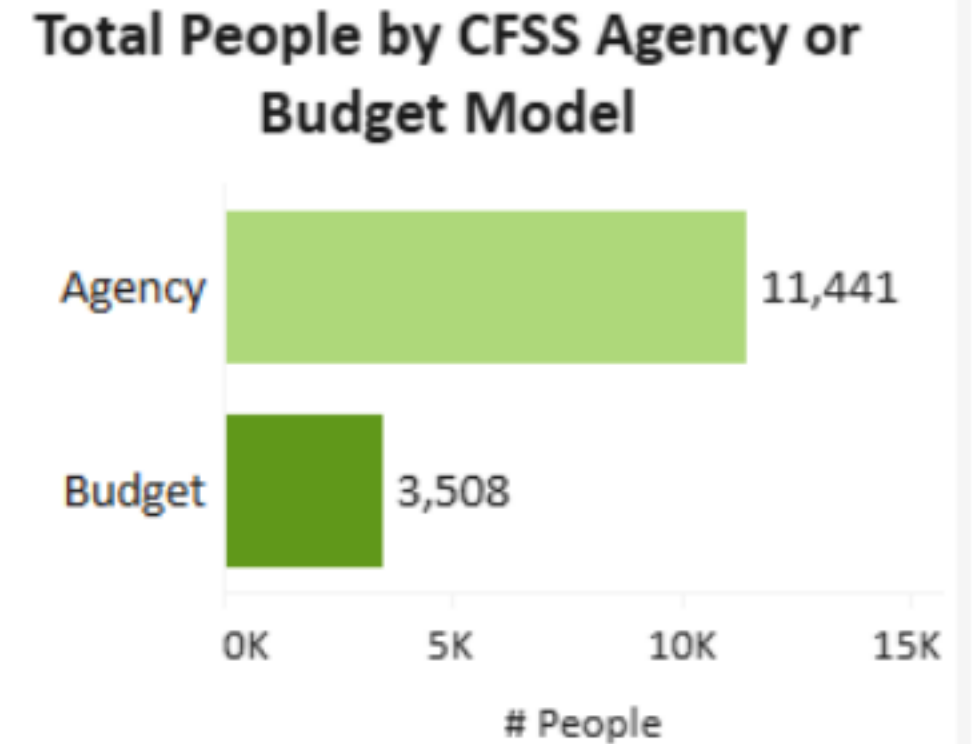
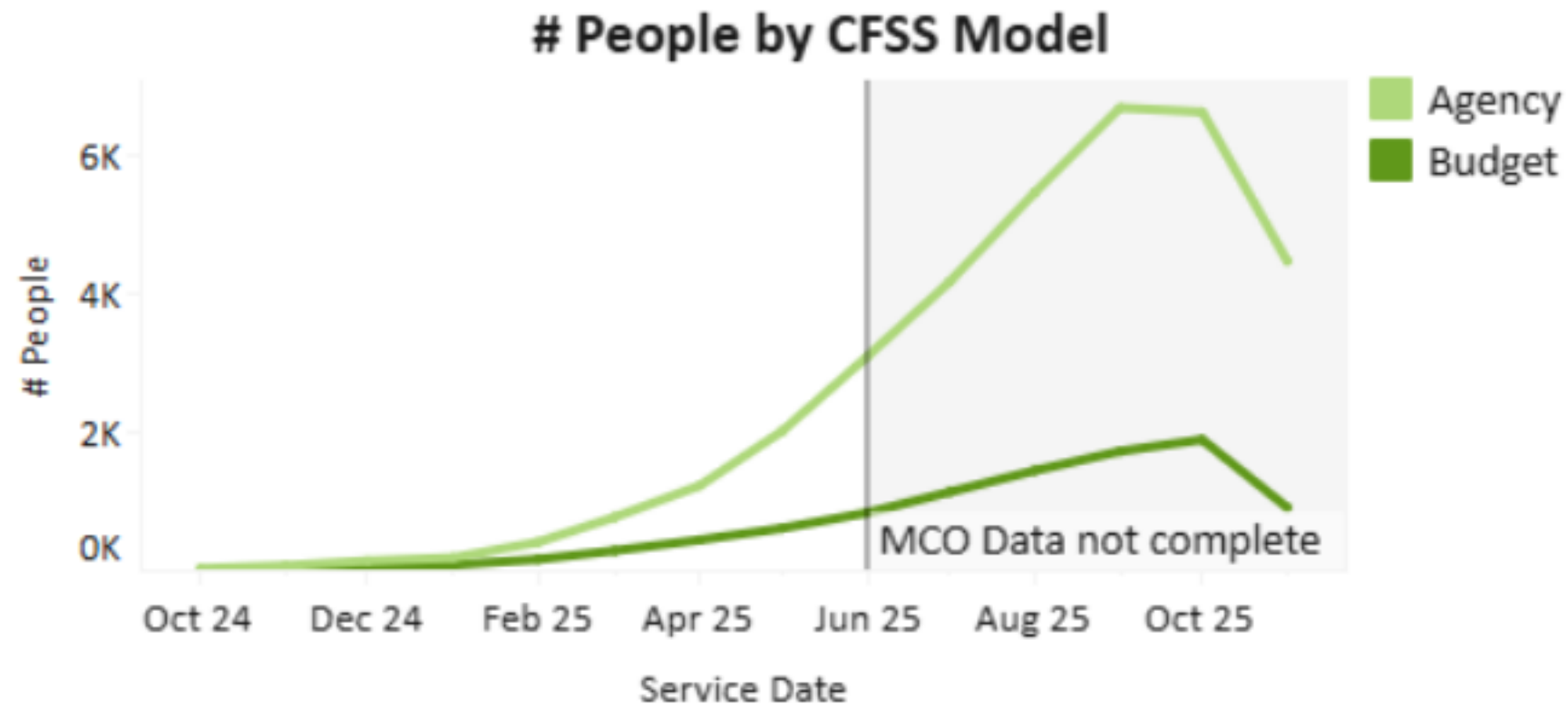

Temporary Approval Update

- For people not on a waiver/AC (have a Type B service agreement), if the reassessment occurs 30 days or less after the end of the existing service agreement, the county/tribal nation uses the date of the reassessment as the start date.
- There will be a gap in service from the date the SA ended until the date of the reassessment.
- Lead agencies must complete the 6893L using the date of assessment as the start date.

1/1/26 rate changes

- 0.13 increase to PCA/CFSS, PCA Supervision and CFSS Worker Training and Development
- 4.79% increase to PCA/CFSS Complex
- 0.13% increase to CSG and PCA ratings.
- The same percentage increase also apply to extended PCA/CFSS.
