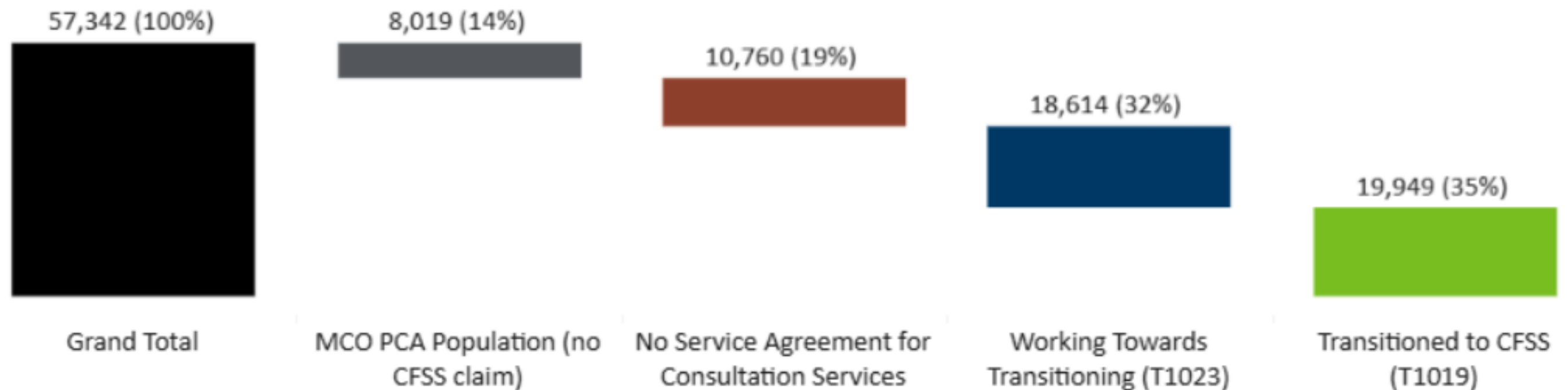

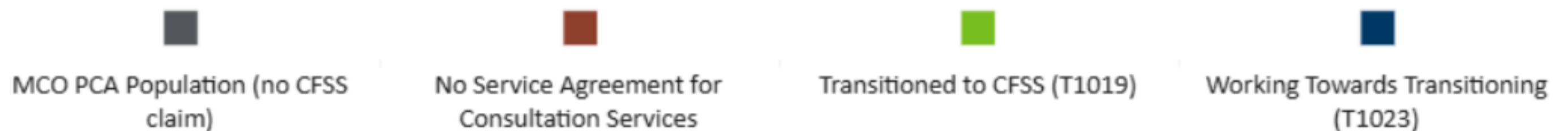

PCA to CFSS Transition Data as of 2/18/26

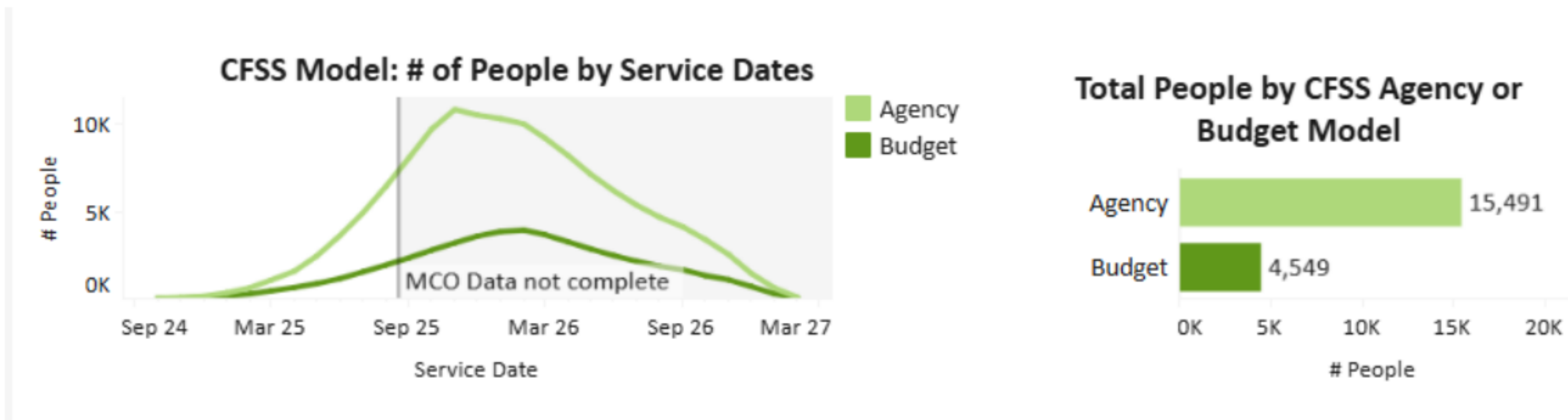
People by Current Transition Status

Revalidation Process

CFSS providers will need to be revalidated by 5/31/26:

- CFSS provider agencies
- FMS providers
- Consultation services providers

Revalidation process includes:

- Review of the providers paperwork
- Background study
- Site visit

6893P after the 6893L (plan after extension)

The 6893P should reflect the entire span year, even if the person has a temporary approval. For example:

- Span is 11/1/25-10/31/26.
- Assessment completed on 10/14/25
- Temporary Service Delivery Plan (DHS-6893L) for 11/1/25-10/31/26
- Service Delivery Plan (DHS-6893P) developed for 11/1/25-10/31/26
- Service Delivery plan (DHS-6893P) submitted to lead agency on 1/29/26
- Service Delivery Plan Addendum (DHS-6893W) for 11/1/25-10/31/26

Referral for Reassessment - REMINDER

- In both PCA and the CFSS agency model, the provider agency is responsible to request a reassessment from the lead agency 60 days before the end of the person's current service agreement.
- The consultation provider does not submit the referral for reassessment.
